JOINT RESOLUTION ON IMPACTS OF COVID 19 IN COMMUNITY OF CROSS LAKE

WHEREAS, the Chief and Council of the Cross Lake Band of Indians and the Incorporated Community of Cross Lake Mayor and Council have jointly declared a State of Emergency for the Community of Cross Lake as of March of 2020.

WHEREAS, the State of Emergency was implemented due to the extremely contagious nature of COVID 19 Corona Virus and it's impeding life threat to the Members/Residents of Cross Lake.

WHEREAS, the State of Emergency was implemented for the safety of all Cross Lake Band Members/Residents of Cross Lake.

Therefore, be it resolved; the Chief and Council of the Cross Lake Band of Indians and the Incorporated Community of Cross Lake Mayor and Council along with the Cross Lake Pandemic Planning Committee support through this resolution the following Community Safety Precautions:

- The Border Check Stop will continue
- All Protocols will be reinstated as required
- All Vehicles/Persons may be subjected to Search for Drugs and Alcohol
- All travel will be medical and essential services travel only
- All Authorization Forms will include a Waiver that must be signed
- All people in vehicle will require a Temperature Check (only family recommended in vehicle)
- Community Curfew in effect from 10:00 p.m. to 6:00 a.m.
- It will be mandatory to wear masks in all public places
- It will be mandatory to follow safe social distancing (6 feet apart)
- It will be mandatory for all businesses to ensure they follow the CLPPC Guidelines
- It will be mandatory for all Cross Lake Band Members/Residents to follow the CLPPC Guidelines
- Absolutely no Large Gatherings allowed in public or private places
- All Educational Institutions will continue to operate at 50% as per School Pandemic Plan (s) If a positive case is identified in the community of Cross Lake all Educational Institutions will automatically shut down.
- All must adhere to Travel Guidelines
- All Contractors must follow Protocol for Contractors Document

- Travel Restrictions will be adjusted through the recommendations of the CLPPC and level of Covid Cases by Region in the Province.
- Norway House Residents allowed until further notice

Further Be It Resolved; As Covid is continuously evolving and will necessitate changes from time to time, the above noted will be in effect until such a time the Cross Lake Chief and Council, Incorporated Community of Cross Lake Mayor and Council along with the Cross Lake Pandemic Planning Committee initiate change.
